During the Feb. 17 Villa Board Meeting, Leslie Bloom was nominated to fill the expired seat she previously had held. The Board approved her nomination and she was appointed as Board Secretary.

Bobcat Villa Rules

As with any housing or condominium community, the Bobcat Villas has a document named the Covenants, Restrictions and Easements (CRE's) that essentially specifies what unit owners can and cannot do. It also spells out the responsibilities of the HOA and those of the unit owners. All Villa owners should have received a copy of the CRE's when you purchased your unit and at that time, signed a document indicating that you received and read them!

A couple of items addressed in the CRE's deserve a regular mention.

STOP AT THE STOP SIGNS! It may seem easy to breeze through the signs as you rush to get to work or play, but there are people who walk, bike and skate around Lynx Run who you may not easily see.

DON'T PARK IN THE PUBLIC PARKING IN FRONT OF THE COMMUNITY CENTER

OVERNIGHT. This area is for guests to the Clubhouse and not for routine parking by residents. If you must temporarily park there, be sure to move your car back to your driveway or garage at the end of the day. HOA is pursuing a hurricane damage claim with the current insurance provider, Littlestone indicated that no other insurance carrier would bid on our coverage until after the claim is resolved. With no competing bid in hand, the Villa's HOA insurance premium will rise from just over \$59,000 last year to \$81,500 this year. That represents a \$21,000, or a 36 precent, increase. Board President BettyAnn Copley explained that the large increase will be offset by money saved on roof repairs that are being covered by Knox Services, the Villa's roofing contractor.

The Landscaping Committee announced that palm trees throughout the community will be cut twice this year - in May and toward the end of October. When the palm cutting is finished in October, mulch will be installed.

The Board cautioned that Villa owners cannot remove pesky trees at their will and own expense. If the tree is alive, it can be trimmed to ease dirt and damage to the Villa property. If it is dead, then the HOA will take of its removal. It is against North Port city statute to remove live trees without cause. Contact Chris McCluskey is you have a tree - for example a pine tree that is dropping waste or growing out of control and needs attention.

The Social Committee submitted a proposal to the Villa Board to have a dishwasher, garbage disposal, new faucet and storage cabinet installed in the Clubhouse kitchen. All costs associated with the project were to be provided by the Social Committee through fundraising efforts and donations. The Board moved to approve the proposal and all items were installed in late February. These kitchen additions will allow for quicker cleanup after Villa social events and for more sanitary washing of glasses, dishes and flatware used during most gatherings.

A new vendor was approved to take on the power washing of sidewalks and driveway aprons throughout the community. Mazzoni is scheduled to be on site March 23-27. A schedule of when they will be where will be distributed closer to their arrival. While they are here, villa owners can contract separately with them to power wash their driveways and walkways from the drive to the front door. The cost for this service is \$55 per unit. Contact information for Mazzoni will be distributed to all owners. If there is any change in the scheduling of this service, an announcement will be made.

Dryer vent cleaning will take place March 16-20. The Board approved the proposal from The Go To Guys to handle this task. It is imperative that all dryer vents be cleaned out as built up dryer lint is a fire hazard. An email has gone out indicating where they will be on each day of cleaning. If you cannot be on hand for your unit's cleaning, make arrangements for someone to let the "Guys" in. If you are renting your unit, make sure your renters know about the cleaning and are on-hand to let them in.
