#### **Landscaping Update**

With the summer rains receding toward the end of August, the Villa Board will move forward with having our landscape vendor LMP lay mulch throughout the community. The particularly heavy rains in the summer washes the mulch off the beds and onto the drives and sidewalks, creating quite a mess!

engineer's report that will detail hurricane damage on each building. This report will be forwarded to the Florida Insurance Guaranty Association (FIGA) in support of our claim of hurricane damage. Our attorneys have heard that FIGA is working to resolve all claims made against our former insurance company, AmCap, by the end of January 2023. Both our roofing contractor Knox Roofing and our attorney remain optimistic about the success of our claim.

#### **Roof Work on Unit 2012**

For over 6 months now, the roof over unit 2012 has been covered with an underlayment material as we await any decision about our insurance claim for total roof replacement due to hurricane damage. We decided to not have the existing roofing tiles re-installed at that time. Knox Roofing is conducting on-going inspections and maintenance of that exposed underlayment and has assured us that it is holding up and preventing any water from leaking through. Some of the old tiles that had been stacked on the roof have been removed to prevent leaf buildup around the super gutter. The remaining tiles will stay until the roof on that unit is replaced. If heavy storms and/or a hurricane threatens, the roofing company will remove those tiles to prevent them from being blown around causing damage to villas and lanais.

#### **Clubhouse Issues**

Chris McCluskey is gathering bids to replace the awning over the back sliding glass door and window of the Clubhouse. The harsh sun exposure, heat and heavy rains have done considerable damage to the awning.

Now that wifi is available in the Clubhouse, Chris has also reached out to the Bobcat Trail security firm Envera about using their services to provide security monitoring in the Clubhouse and pool area. He is awaiting further information from Envera.
