From the April Villa Board Meeting

The Villa Board of Directors met on Thursday, April 6 at 4 pm in the Bobcat Trail Community Center.

President Lou Sperduto reported that our landscape partner LMP continues to work on repair to our irrigation system. Much of the repairs result from damage from Hurricane Ian.

He also reported that after meeting with the Villa Landscape Committee, it was decided to install Queen Palms in places where other palms were toppled over or otherwise destroyed by the hurricane. Additionally, any sod removed to plant the trees will be re-used to fill in open spaces in the lawns now. This is a cost-saving effort to the make best use of landscaping funds.

An Update to Our Roof Replacement Claims

Since the March Villa Board meeting when actions to date were presented in full detail, a couple things have occurred.

As reported during the meeting, a lawsuit was filed against the Florida Insurance Guaranty Association (FIGA) on our roof claim resulting from Hurricane Irma. They had 20 days to respond. Their response was to send an inspector out to look at our roofs. He indicated that he was going to do a drone fly-over to get a better feel for what shape our roofs are in. We believe his report will be used by FIGA in their response to our lawsuit.

But remember from the meeting, we had an engineering firm do a full assessment of the state of our roofs just before Hurricane lan hit. It separates the Irma damage from that resulting from lan. According to our lawyers, that stands a crucial piece of evidence in our case.

We then had Socotech, the engineering firm, do a comparison report of Irma damage versus lan damage that will be provided to both insurance entities.

As further actions are taken and information provided by both FIGA and our lan insurance companies, we will forward them along.

Roof Insurance Claim Update

Then the discussion turned to a thorough update on efforts to secure funds for total roof replacement from claims filed with both insurance companies involved.

A complete accounting of the the discussions related to the topic, from an insurance industry update, to the timeline for the claim filed from Hurricane Irma, to the more recent claim for Hurricane Ian, to actions taken to date and to continue while these claims are settled, was distributed to all Villa owners via email and is posted on the bulletin board in the Breezeway of the Villa Clubhouse.

At the conclusion of the presentations, the Board assured owners that they will continue to keep everyone informed as to actions that unfold over time, particularly during scheduled Board meetings.
